A doubt has been raised as to the reporting authority and reviewing authority in the case of CAO (TR) wherever DGM (TR) is also posted in SSAs.

As per Para No.4.0 of reporting and reviewing structure at SSA office (all cadres) circulated vide BSNL, ND letter No.4-2/2010-restructure dated 20.09.2010,

"First line of reporting [DGM (F) in this case] indicates the officers who are directly reporting to SSA heads and second line of reporting [DGM (TR] wherever posted or CAOs indicates the officers reporting to the first line [DGM (F)]."

As DGM (TR) in SSAs is the second line of reporting, who are reporting to the DGM (F), who is the first line of reporting, the reporting and reviewing authorities are elaborated as follows:
