
Subject:- Implementation of the judgment dated 11.1.2010 of the Hon'ble High Court of Kerala, Ernakulam Bench, in WPC No. 30551 of 2009 - Shri Sunny Philip (ST No. 10979), Smt Mariamma John (ST No. 11137) and Sh T M Santhamma (ST No. 11371) .

In pursuance of the judgement dated 11.1.2010 in WPC No. 30551 of 2009 filed by Shri Sunny Philip (ST No. 10979), Smt Mariamma John (ST No. 11137) and Sh T M Santhamma (ST No. 11371) , the competent authority has decided that the order bearing No. 232-32/87-STG-II dated 17.5.1991 issued by DoT, promoting the aforesaid three officers to TES Gr B equivalent to SDE(T), may be restored.
