Sub: Billing of revenue share of circuits (point to point circuits) between MTNL and BSNL -Reg.

Please refer to our letters of even number dated 02.04.2013 and 08.04.2013 on billing of revenue share of circuits between MTNL and BSNL. In this regard, various communications have been received from circles asking to clarify certain points. Some clarifications sought for by circles and their replies are as follows:

SI	Clarification on	Reply
1	Whether the billing procedure is applicable for all the connections to be provided in future and also for the bills to be issued from 01.04.2012 onwards for the existing connections.	As per letter of even number dated 02.04.2013 vide para 3, it was stated that "the billing procedure as indicated below may be followed by the billing authority in both BSNL and MTNL for all the point to point circuit connections to be provided in future and also for the bills to be issued from 01.04.2013 onwards for the existing connections" i.e. all the bills with bill date from 01.4.2013 onward.
2	For billing 75% share for leased circuits being billed at present by MTNL, the details to raise the bills of BSNL share is required. As such details of Nodal authority of MTNL for this purpose may kindly be intimated so that the matter can be taken up with MTNL.	EB unit of Circle/SSA will co-ordinate with MTNL Delhi & Mumbai for Nodal Authority of MTNL and vice versa for each and every circuit.
3.	As per point 3(A)(ii), the front ending entity may present both the invoices to the customers. In this connection, one has to wait for bills from other units then it may not be possible to issue bills in time. Hence, some time frame may be decided to submit invoices to each other to avoid delay in billing.	EB unit of circle/SSA will co-ordinate with MTNL Delhi & Mumbai for Nodal Authority of MTNL and vice versa for each and every circuit as well as time frame to submit bill on each other and identify the circuits to be billed in every month and provide the details to the nodal authority in advance to get the bills from other units.
