Subject: Online automatic monitoring of Exchange Alarms through RAISE software-Regarding

Kindly refer to the letter dated 26.04.2011 of this office vide which the decision of competent authority to implement "Online Automatic Monitoring of Exchange Alarms" in wire line network was communicated. The same was to be implemented in all SSAs in two phases. Subsequently, a website <u>http://raise.bsnl.co.in</u> was also got developed to make the all required information/ resources available at single place.

Once fully implemented, the above system will help BSNL in improving the QoS of wire line network tremendously. The some of the advantages expected from the system are:

- 1. The above website is to be used as centralized monitoring server for collecting and monitoring the switch alarms generated by various switches and for automatically generating the necessary reports especially the Exchange failure.
- 2. The above will enable all concerned to see the performance of switches in real time and take necessary corrective measures immediately. The system has the capability to send SMSs for Critical/Major Alarms to concerned persons.
- 3. Various historical reports are also to be made available for overall performance analysis of switches/network.
- 4. Later on, the Transmission/Media alarms and alarms generated from other equipments such as DSLAMs, Fire Alarms are also to be collected through this system.
- 5. Being the in-house product of BSNL, there is no cost involved in implementation and operation of the system.
- 6. System works on existing IT Infrastructure and doesn't require procurement of any additional hardware.
- 7. Once installed, system works automatically and doesn't require any user intervention to operate.

As already conveyed whole of the work was to be completed by 30.06.2010. However, only few SSAs till date have implemented the same. The existing connectivity status is available at Annexure-I.

Seeing the various advantages of above system it has been decided by Director (CFA) to connect all the switches with the above system by 30.11.2011 positively. The above work is to be completed as a project in time bound manner. The connectivity of all SSAs is to be completed in Phase wise manner as per following timeline:

The first report must be mailed by 18.10.11.** Before sending the report, circle must login to the above website (http://raise.bsnl.co.in) to verify that their SSA based RAISE server is uploading Alarm data successfully to central web server at Bangalore. Such SSAs where C-DOT based LNMS system is already working may continue to use the same till further instructions by this office.
