– Errors and Omissions – regarding

This office is in the process of preparing the seniority list of SDEs(T) promoted to the grade in BSNL after its formulation. A list (enclosed) comprising the name, category, Staff number, HRMS No, DOB, particulars of promotion order and the vacancy year in respect of **competitive quota officers**, who were promoted on the basis of LDCE, 2007, has been drawn with a view to inviting errors and omissions.

2. The vacancy year shown against individual officer in the enclosed list has been assigned based on the merit position, the number of vacancies reported for a particular year and the number of officers declared qualified as per eligibility against that year.

3. It is presumed that the officers in the list have fulfilled the requisite eligibility condition of three years regular service in JTO grade for being promoted as SDE(T) against a particular vacancy year in accordance with Recruitment Rules, 2002 of SDE(T). If any officer is found short of the requisite eligibility condition of three years regular service against a particular vacancy year as per the Recruitment Rules, his promotion as well as seniority will be reviewed independently or pursuant to final decision of Tribunal or Court, if any.

5. Circle office and all concerned are requested to go through the list and bring to the notice of this office any errors or omission in respect of Name, Staff No, HRMS No, Category, DOB etc with supporting documents through proper channel. Promotion Orders that have not been implemented due to refusal of promotion or pendency of disciplinary case or currency of penalty or any other reason may be reported separately. Direct representation received in this regard shall not be entertained.

6. The list may be given wide publicity and errors and omissions thereof may be reported to this office through proper channel within two months of the date of issue of the letter.
