1. All the above executives have been considered for promotion to the grade of Accounts Officer on the basis of ACR/APAR grading furnished by the concerned SSAs/Units. In such cases he /she should not be promoted and the matter should be reported to this office immediately. In cases where any of the above mentioned conditions are met resulting in non promotion of the executive, the same may be immediately brought to the notice of this office along with details.
2. In respect of the executives who have been transferred to other circles, they are promoted to the grade of Accounts Officer subject to the conditions referred in para (3) above and will be relieved on receipt of place of posting from the concerned circles but not later than 06.02.2015. Hence, the executives mentioned at Sl.No.6,12,23 & 61 are instructed to submit necessary charge report as AO to the office in which they are presently working.
3. On promotion to the grade of Accounts Officer the pay of the executives will be fixed as per the instructions issued vide OM No. 1-50/2008-PAT (BSNL) dated 05-03-2009 read with letter No. 400-61/2004-Pers. I dated 18-01-2007 and further modifications issued from time to time if otherwise applicable.
4. If the executives are on leave / training, they shall be promoted after return from such leave /training.
5. Any other discrepancy, viz variation in the name of the executive, staff No. category etc. shown in the order may be brought to the notice of this office with supporting documents for rectification of records.
6. The leave, if any requested by the executive who are under transfer, should not be granted under any circumstances by the SSAs/Units where they are presently working. The executive may apply for leave to the Competent Authority of the new place of posting, who will sanction the same if it is justified in the normal course.


