Operation Stream - CANCELLATION - - reg.

In pursuance of BSNL Corporate Office New Delhi order No. 412-10/2015-Pers.I (PT) dated 14/07/2015, and in partial modification to BSNL CO ND Lr. No.412-23/2014-Pers.I dated 11-03-2015 (copy communicated vide this (O) letter No. TSA/10-141/2014 dated 11-03-2015) wherein the "Forgone order" of Shri. B.BASKARAN, (Staff no.35497 & HRMS No. 198000335) SDE Tirunelveli SSA of Tamilnadu Telecom Circle were issued stands withdrawn, with immediate effect. The earlier regular promotion orders No. 412-16/2014-Pers.I dated 20-08-2014 vide which the Executive was promoted is again restored.

2. The Executive who is working as Sr.SDE / SDE in Telecom Operation Stream, is hereby promoted on regular basis to the AGM /DE in Telecom Operation Stream with immediate effect or from the date the executive assumes the charge of the post, whichever is later as per BSNL Management Services RRs dated 14/07/2009 and subsequent amendments, in the IDA Scale of pay of Rs.29,100-54500/- and on his regular promotion the Executive is posted to Tamilnadu Telecom Circle.

- Due to any direction from Hon'ble Court/CAT for not effecting the promotion to an individual.

All such cases may be brought to the notice of this office immediately for taking appropriate action.

5. The charge reports submitted by the Executive(s) in pursuance of aforesaid promotion order may be sent to all concerned and entries be made in HRMS/ERP.

6. Pay fixation applicable to the executive may be done in accordance with BSNL order no. 1-50/2008/PAT(BSNL) dated 05/03/2009 read with BSNL Order No. 400-61/2004-Pers.I/308 dated 18/01/2007 and subsequent orders issued from this office time to time.

7. This promotion order, however, is subject to the outcome of the SLP@ No.32284/2013 & ors, challenging Hon'ble Kerala High Court order dated 01/07/2013 and any other case(s) pending in various Hon'ble Courts.

In case the Executive(s), reverted / demoted or their seniority is re-fixed as per the outcome of pending SLPs/Court Cases, such executive(s) will not be entitled to hold the promoted post and any pay protection or any other benefit attached thereto.

8. If, any Executive who is placed to E4 Scale due to this promotion order, will have to undergo two weeks mandatory E3-E4 training within stipulated period as prescribed in EPP and clarifications issued from time to time for drawing second increment.

9. In case, the Executive is under transfer / temporary transfer from / to any other Circle / SSA/ Unit as SDE or otherwise, he may be directed to join as AGM/DE (Regular) on promotion in his parent SSA.
