As per the instructions contained in BSNL HQ Letter cited above, approval of the Chief General Manager, BSNL, Tamilnadu Circle, Chennai -600 006 is hereby conveyed for extension of temporary transfer of Sri . B Niranjan, PA AP Circle,. to Thanjavur SSA of Tamilnadu circle for a period of One year from 03.04.2014 upto June 2015 subject to the following conditions.

- i) The temporary transfer will be at his own cost/request
- ii) The official will not claim TA/DA/Joinig time etc.
- iii) The official will not claim regular absorption in the New Unit.
- iv) The pay and allowances of the official will be drawn by the unit where he joins on temporary transfer for a period of one year
- v) He will be in the gradation list of PA of A P Telecom Circle.

The extension of temporary transfer for period beyond 03.04.2014 and upto June 2015 to Shri B Niranjan, PA, is also subject to the condition that in case the post against which the temporary transfer has been made is filled by regular/adhoc candidates of the concerned circle, the official on temporary transfer against this post shall remain automatically repatriated to his parent circle without any prior notice in this regard or

whenever the BSNL Administration desires to do so in the interest of service. There shall not be any further extension of his temporary transfer from AP Circle to TN Circle beyond June 2015.

Before the issue of the orders of relief, necessary undertaking may be obtained from the official to the conditions(i-iii) and forward the same to this office without fail.

The official may be relieved to AP Circle on completion of the said period of extension without **waiting for further directions.**
