In ^{partial} cancellation of this Office memo cited under reference, the following officer of Regular STS of Executive Grade (Telecom), who was reverted as DE on 16/08/2013 A/N due to STS regular promotion, is hereby ordered to look after the current duties of the JAG of Executive Grade (Telecom) as detailed below, with effect from the date noted against him for a period not exceeding 90 days or till the date of retirement, whichever is earlier, under the following conditions.

This looking after arrangement is made on local ad-hoc basis and this will not confer any right on him to continue in the post/station/grade.

The officer may be reverted automatically on completion of 89th day of looking after or regular incumbent joins whichever is earlier without awaiting orders from this office.

It may be noted that separate reversion orders for the officer will not be issued from this office henceforth. However the date of completion of 89th day may be intimated to this office one month in advance.

On termination of this looking after arrangement, the officer will be reverted to his regular post from where he is promoted unless otherwise ordered in the meanwhile. In case any vigilance/disciplinary case is pending / contemplated against any of the officer or any punishment like stoppage of increment is current, the looking after arrangement should not be given effect to in respect of the officer and the fact should be intimated to this office immediately

The above arrangement is purely temporary and is likely to be withdrawn at any time without assigning any reason.

Any request for change of posting will not be strictly entertained. The officer may be relieved as ordered above immediately so as to assume the new assignment. In case the officer is not willing and does not join the new post as stated above, the order will automatically stand cancelled in respect of the officer and the officer will be debarred for a period of one year from the date of issue of the order. In case the relief of the officer is deferred due to administrative reasons, the same may be intimated to this office immediately.

The relief of the officer should not be deferred on the ground that the officer has given a representation. In case any of the officer is not willing to take up the assignment due to any reason, the same may be obtained in writing from the officer and forwarded to this office immediately.

The above arrangement is without any extra remuneration/fixation benefits. The officer shall not exercise the statutory powers of JAG of ITS Group 'A'.
