Sub:Regular promotion to the Executives in AGM /DE of Telecom Operation Stream in the IDA Scale of Rs.29,100-54500/- - reg.

In pursuance to BSNL Corporate Office New Delhi order No. 412-16/2013-Pers.I dated 25/10/2013, the Executives working as adhoc Executive or Sr.SDE / SDEs in Telecom Operation Stream as per the details indicated in the enclosed Annexure, are hereby promoted on regular basis to the AGM /DE in Telecom Operation Stream, as per BSNL Management Services RRs dated 14/07/2009, in the IDA Scale of Rs.29,100-54500/with effect from the date of assumption of the higher post. These Officers on their regular promotion to AGM/DE grade will continue to remain posted in their existing SSAs / Units, till further orders. However, the Officers who were retained in their present Circle in earlier orders will continue to stay in the present Circle till the end of their retention period, thereafter, they shall automatically stand relieved from their present Circle for the allotted Circle.

- 2. The officers shall however, not be promoted by the concerned SSAs / Units, in case:
 - i. Disciplinary / vigilance case is pending.
 - ii. The officer is under the currency of any penalty.
 - iii. The officer is on deputation to TCIL etc.
 - iv. Presidential Order is not issued due to any reason.
 - v. If the Seniority Number or Staff Number or the category is different from the details indicated in the enclosed list.
 - vi. Due to any direction from Hon'ble Court/CAT for not effecting the promotion to an individual.

All cases covered under the above clauses, may be forwarded within 15 days, from the date of issue of this order to this Office, for taking appropriate action.

- 3. The charge reports submitted by the Officers in pursuance of aforesaid promotion order may be sent to all concerned.
- 4. The promotion order is subject to the outcome of various Court Cases pending in several Hon'ble Courts, including SLP filed by BSNL in Hon'ble Supreme Court.

Pay fixation applicable to the executives may be done in accordance with BSNL order no. 1-50/2008/PAT(BSNL) dated 05/03/2009 read with BSNL Order No. 400-61/2004-Pers.I/308 dated 18/01/2007 with the option to choose the date of pay fixation in terms of FR22(1)(a)(1) within the prescribed time limit therein. Accordingly, the officers may give their option for fixation of pay within one month of issue of their promotion order.

The Officers presently looking after as DGMs, are reverted as adhoc DEs by the afternoon of 25/10/2013 and promoted on regular basis into STS equivalent grade on 26/10/2013. Copies of charge report may be sent to this Office and to all concerned.
