Before implementation of this order, it should be ensured that Presidential order for absorption of the executive in BSNL has been issued and executives to be promoted are working in the grade of STS [CAO] on regular basis in the Circle.

On promotion, the pay will be fixed as contemplated in BSNL MS RR, communicated vide No. 400-106/2007-Pers I dated 14-07-2009 and further modifications on the subject issued from time to time.

The Executives are required to join their assignment on promotion within a time period of 30 days from the date of issue of this order to the concerned SSA.

The executives would not have any claim for their seniority/regular service in DGM's grade of Telecom Finance based on this ad-hoc promotion. Their seniority will continue to be determined with reference to his basic seniority in the substantive grade of CAO of Telecom Finance Service [STS level].
