**Subject : Identification of sensitive and non-sensitive posts.**


Your attention is invited to the D.O. letter No. 17-8/99-VM.I, dated 7<sup>th</sup> January, 2000 of the DOT regarding the rotation of officers working in sensitive posts.

With the passage of time, it has been desired to have a re-look on the sensitive/ non-sensitive posts and the rotational transfer. Therefore, in consultation with the Management, the list of sensitive work / section has been revised and enclosed as Annexure I. Based on this new criteria, it is requested to send the data (in MS Excel sheet) which are identified as sensitive in the Circle/Unit as per proforma enclosed as Annexure II. The data may also be sent on e-mail I.D. [sbalaji1@bsnl.co.in](mailto:sbalaji1@bsnl.co.in) by 31.12.08.

As per the CVC guidelines officers / officials posted on the sensitive posts are to be rotated in every 2-3 years (copy enclosed at Annexure-III). Also no delinquent officer/official is to be posted on sensitive post. As a certificate is to be submitted to the CVC, therefore, you are requested to initiate immediate action for implementation of the CVC guidelines. The posting of officers/officials on sensitive posts is to be reviewed by the Vigilance Heads on six monthly basis. The non-compliance report in the form of officers/officials who have been continuously posted on the sensitive posts for more than three years and delinquent officers/officials posted on sensitive post may be submitted to the CVO, BSNL by 15<sup>th</sup> January and 15<sup>th</sup> July every year in the same proforma enclosed as annexure-II.
