A kind reference is invited to this office letter No.TAC/Spl. Cell/67-40/2010/17 dated 28.05.11 seeking clarification on the methodology to be followed for fixation of pay in the case of officials who have opted for fixation of pay from the date of promotion. No reply has been received from Corporate office, so far.

It appears that the methodology to be followed is that the official may be allowed to retain the pre-revised IDA scale of lower post till the date of his promotion and then the pay is to be fixed in the I PRC scale of promoted post and subsequently the same is refixed in II PRC pay scale after adding fitment benefit of 30% and merger of DA at the rate of 68.8%.

It is seen from a copy of pay fixation memo dated 08.06.2011 (copy enclosed) in respect of Shri Vipin, TTA, Corporate office issued by AGM (Pers.IV) that the above procedure is followed for fixation of pay in II PRC.


