As per Rule 56 to 61 of CCS (Pension) Rules 1972, the Head of office should start collection of pension papers and preparation of all other relevant records 24 to 30 months ahead of the Superannuation date and send pension papers to the Accounts Officer concerned not later than 6 months before the date of retirement.

It is requested to issue suitable instructions to all concerned to ensure that future Superannuation pension cases are submitted to DOT Cell according to prescribed time limit or at least 2 months before retirement of the official in advance, so that the pension cases are settled well time.

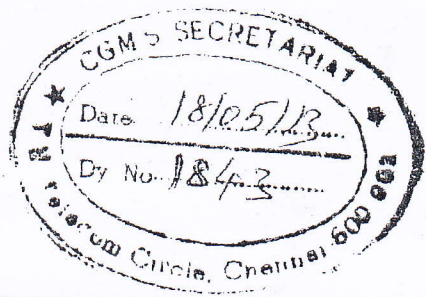

I would like to bring to your notice, the abnormal delay in submission of superannuation pension claim papers from the SSA Units.

As per the orders contained in Rule 56 to Rule 61 of CCS (Pension) Rules 1972, the Head of the Office should start collection of Pension papers and preparation of all other relevant records 24 to 30 months ahead of the superannuation date and send the pension cases to the Accounts Officer concerned not later than six months before the date of retirement. But it is pertinent to mention here that many of the SSAs fail to observe the time schedules prescribed in Pension Rules.

During the current month, 128 officials are retiring as on 31.05.2013, and only 95 cases have been received as on date and 33 cases are still due from the respective SSAs. Details of the pending cases of retiring officials are furnished in the enclosed Appendix 'A'.

The non-receipt of remaining cases may cause much pressure on this office, if cases are sent late (we being an ISO certified office, have promised to decide the case on the last day of the month).

I therefore request you to kindly instruct the concerned SSA Heads to submit the pending cases at once and also ensure that the future superannuation pension cases are submitted to this office according to the prescribed time limit or atleast 3 months before the retirement of the official, so that superannuation cases are settled well in time.
