Subject: Clarification regarding applicability of 20% discount on Broadband Service charges (usage and rental) in respect of newly introduced BB Plan viz., (1) BB Home UL 499 Plan and (2) BB Home Combo UL 625 Plan-reg.

Kind reference is invited to this office circular No. 64-03/08-Broadband dated 01.12.2008 through which BSNL introduced the scheme of allowing 20% discount on Broadband Service charges (usage and rental) for Broadband connections provided to Central Government/State Government/PSU employees. Reference is also invited to this office circular No. 10-3/Comm./2009-R&C dated 08.04.2009 through which the same benefit was further extended to visually impaired customers.

- A few units have sought clarification regarding applicability of 20% discount on Broadband Service charges (usage and rental) in respect of newly introduced BB Plan viz., (1) BB Home UL 499 Plan and (2) BB Home Combo UL 625 Plan.
- 3. In this regard it is hereby clarified that, "20% discount on FMC and Usage charges on Broadband Service is applicable for connections provided under newly introduced BB Plans viz., (1) BB Home UL 499 Plan and (2) BB Home Combo UL 625 Plan, to the Central Government/State Government/PSU Employees as well as visually impaired customers as prescribed vide circular No. 64-03/08-Broadband dated 01.12.2008 and No. 10-3/Comm./2009-R&C dated 08.04.09."
- Moreover, certain units have sought clarification regarding applicability of 20% discount on FMC and Usage charges on Broadband Service for the connections provided to the staff/officers of BSNL. In this context, it is clarified that 20% discount on FMC and Usage charges on Broadband Service is not applicable to the Broadband Connections provided to the staff/officers of BSNL, as the Broadband Connections are provided to them on concessional basis or as residential service Broadband connections.
- 4. These instructions may be brought to the notice of all concerned for taking necessary action.
