 User ID and Password will be sent via SMS to their Mobile number. The competent authority in each SSA shall approve a list of eligible officials according to the particulars required in Sancharsoft.
- After ensuring an approval letter from competent authority and respective Proofs like Identity / Address Proof, the data entry can be done by CSC and the same will be made available for sanction by

- CSCs are requested to fill up all the columns with correct particulars for proper creation of the numbers.
- It is the responsibility of the Nodal Officer to verify the genuineness of the details submitted by BE and he can approve the same. On approval, the number will be created in HLR and IN through Sancharsoft. If any discrepancy is found in proof /information pertaining to that BE, the same can be rejected by Nodal Officer citing the reason in the module. - Shortly a Menu will be developed for deletion of CUG Member from CUG Group due to any reason other than SUPERANNUATION.
- CSCs can make entry for service Postpaid Numbers working in the SSA in the front end of Sancharsoft. The list of Service post paid numbers shall be approved by the competent authority of that SSA.
- Calls from Prepaid CUG numbers to Service post paid numbers will be free, whereas vice-versa is chargeable, due to technical difficulties in the billing system.
- On implementation of this new Prepaid CUG for RMs and TMs, service Postpaid CUG provided for them in some SSAs shall be closed.
