While providing the service connections, the following conditions may be adhered to:

- That the service GSM connection is provided without handset. The WLL service connection if already provided is to be de-activated and instrument recovered.
- The CUG facility may be provided free of cost and is restricted to official service connections of the concerned SSA only.
- GSM connections to other **select Non-executive**, other than RMs/TMs working in O/Ds, shall be provided only with the **personal approval of CGM** as enumerated in BSNL HQrs Ir.No.2-22/2002-PHA dated 12.06.2008.

Subject:- Provision of pre-paid SIM with a talk time of Rs 200/-pm to Telecom Mechanics /Regular Mazdoors who undertake out-door duties and select non Executives on the basis of functional need.

The issue regarding provision of pre-paid SIM with pre-paid talk time to Telecom Mechanics /Regular Mazdoors who undertake out-door duties and select non-Executives on the basis of functional need in area where "CDMA" coverage is not available or Hand sets are not available ,has been under consideration .The following has been decided with the approval of the Management Committee of BSNL Board to :-

- 1) Provide a Pre-paid GSM SIM with a talk time of Rs 200/- pm to:-
 - a) Telecom Mechanics /Regular Mazdoors who undertake out door duties, and
 - b) Select non- Executives on the basis of functional need as per Circular No. 13/2008-PHA dated 12.06.2008.
- 2) These mobile connections should be provided with CUG facility free of cost. The CUG list will consist of official connections of the concerned SSA.
- 3) Circles where WLL is working can launch prepaid WLL plan within the annual limit of Rs 2400/- pa.
- 4) The officials who were provided with WLL hand sets have to surrender them if provided with GSM connection.


The other terms and conditions will remain the same as per circular No.13/2008-PHA dated 12.06.08.

Sub:- Sanction of WLL(M) Service Telephone Connection to Phone Mechanics - regarding.

As per the existing instructions WLL (Limited Mobility) service telephone connections are allowed to phone mechanics posted in exchanges located in rural areas and outdoor phone mechanics in NCR towns, state capital towns and towns having competition in basic telephone services from other private telecom operator(s).

2. The policy for sanction of WLL(LM) service connections has been reviewed by the management committee in its meeting held on 4.4.2008 and following decisions have been taken.


- i) Regular Mazdoors were who are looking after work of phone mechanics may also be provided WLL[LM] service connections in accordance with existing instructions issued vide this office letters dt. 11.7.2005 and 10.10.2005 referred above.
- ii) Wherever and as soon as the Phone Mechanic is posted again in place of the Regular Mazdoor, such WLL(LM) connection shall be taken back from Regular Mazdoor and given to the Phone Mechanic.
- iii) WLL(LM) service telephone connection may also be provided to all Phone Mechanics (and the RM in case a RM is looking after the work of Phone Mechanic) who are utilized for route patrolling in outdoor sub-divisions in all Maintenance Regions.
- iv) In case it is considered absolutely essential on the basis of functional need, WLL(LM) service connection may be sanctioned on very select basis to non-executives not covered in the existing policy. However, such connections should be sanctioned with the personal approval of the CGM in the normal channel of reporting in circles and concerned Director in Corporate Office.
- v) In specific cases where area of operation of an employee falls in more than one SDCA, the 95 facility, if considered absolutely essential, may be provided with the personal approval of the CGM in the normal channel of reporting.
- vi) Access from all the WLL (Limited Mobility) service connections provided to Phone Mechanics (and Regular Mazdoor in case a RM is looking after the work of Phone Mechanic), including the connections already provided, shall be restricted to only level '2' phones of BSNL. Access to STD, level - '95', other

- level - '9' (including level 94 of BSNL) as well as any other levels of private operators shall be barred.
- vii) All WLL (LM) service connections shall be provided under 'BSNL One India Tariff Plan' without any plan charges and the free usage limit shall be limited to Rs. 300/-. The calls in excess of the free limit made in the interest of service shall also not be charged if the same are counter signed by an officer holding SAG level post or above in the normal channel of reporting.
- viii) The WLL(LM) handset shall be provided and maintained at BSNL's cost, as at present.
- ix) The existing policy regarding loss/theft of Mobile handsets as prescribed vide letter No. 2-7/02-PHA dated 29.8.2002(circular No. 15/02) shall continue to apply for handsets in case of WLL (LM) service connections.
3. The other terms and conditions of this policy shall remain unchanged.
