



Sub:-Revision of flat rates of licence fee for departmental Qtrs w.e.f. 01.07.2013-Reg.

In BSNL, flat rates of licence fee for departmental Qtrs are being charged as fixed by the Directorate of Estates, Ministry of Urban Development & Poverty Alleviation, Govt of India from time to time.

2. The Directorate of Estates vide its O.M.No.18011/1/2013-Pol.III dated 21.11.2013 has revised the flat rates of licence fee w.e.f. 01.07.2013 and the same are enclosed as Annexure-A. Accordingly, approval of the competent authority is hereby conveyed to make recovery of the licence fee w.e.f. 01.07.2013 for the departmental Qtrs as per revised flat rates shown in Annexure-A of this letter. This would also be applicable to those DOT/Govt employees occupying BSNL accommodations.

3. It is also intimated that recovery based upon this order will not be effected in r/o those employees who have retired/resigned from BSNL and have vacated residential accommodation allotted by BSNL up-to the date of issue of this order and Such cases may not be re-opened.
