This office recent letter on the above subject (copy attached) may
be referred. CGM during one of his Administrative Inspection in SSAs,
has observed that RSTC lines are working even after retirement of
officers. This is being viewed very seriously, in the light of Corporate
Office instructions to rationalize and restrict all service connections to the
barest minimum.

Heads of SSAs are hence asked to verify all BSNL service
connections (both Landline and Mobile) of retired officers pertaining to
their respective SSA (including connections working for retired officers of
Civil/ Electrical/Architect /STR/STP/ and **immediately regularize all
mobile/ residential connections accordingly.** (ie) All RSTCs to be
converted into Retired BSNL Employees Category connection after the
eligible retention period of two months from the date of retirement.

Similarly, all BSNL service mobile connections of retired officers
**should invariably work as a paid connection from the next day of
retirement.** . SSA Heads are requested to co-ordinate with Sanchar soft
Coimbatore/ Trichy for verification in this regard and deactivate such
connections which are still working as service connections.

Kindly refer this office letter cited above (copy enclosed for reference) on the subject mentioned. It has been observed that GSM connections of officers /Officials already retired are still working as service connections without conversion into paid connections. Similarly Residential connections which are working as service connections continue to work without conversion into Retired employees category.

SSA / Unit Heads are requested to look into the matter personally and streamline all mobile service post-paid connections working in the SSA **through the HRMS package** and ensure that only **employees in service alone** are utilizing the facility and disconnect **immediately** such connections which are working as service connections for retired /VRS/ expired officers. Similarly , Residential Service connections should be converted to BSNL Retired Employees Category after observing usual formalities.

In respect of Civil/ Electrical /Architect Units working in various SSAs, the Unit Officer of the respective Civil/ Electrical/ Architect Unit should immediately issue instructions and ensure that the service mobile connections issued in official capacity is converted into private paid connection immediately on retirement of any officer working in his unit. Similarly residential service connections should be converted to BSNL Retired employees category.

Based on the above. **Heads of Civil/ Electrical/ Architect** are requested to have a review of the Service Connections (Mobile and RSTC) in their respective Wings (ie) Civil/Electrical/Architect Units in SSAs) and instructions may be issued to disconnect all such connections still working under service category for retired officials and action may be taken to recover the usage charges including rent, from the retired officer/officials, due from the date of retirement or VRS as the case may be.
