The suitability of the Executives due for pay scale up gradation is to be assessed as per the grading criteria outlined in par 1(c) (3)*of EPP-2007. In cases where ACRs/APARs are not available/not written for the reckoning period, instructions contained in DoP&T O. M. No. 22011/5/86 -Estt. (D) dated 10.4.89, 20.06.1989 and corrigendum dated 13th July, 1989, and 22011/5/2013-Estt(D) dt 9.5.2014, as amended from time to time may be followed. This may be subject to other related guidelines being fulfilled (like taking certificate for non-availability of

Doubts have been raised by various Circle office(s) regarding the effect of EOL/CCL etc. on pay scale up gradation under EPP-2007 have been examined. The following clarifications are provided.

SI.	Description	Clarification
1	EOL with Medical Certificate	The period will be counted towards residency period for up gradation.
2	EOL without Medical Certificate for pursuing higher studies	The period will be counted towards residency period for up gradation.
3	EOL in other cases	The period will not be counted towards residency period for up gradation
4	Child Care Leave	The period will be counted towards residency period for up gradation since CCL is to be treated like EL and sanctioned as such in terms of DoP&T OM No. 13018/1/2010-Estt (Leave) dated 18.11.2008.
