Sub: Report of the Committee constituted to look into the aspect of granting residency period w.e.f. 1.10.2000 to Grade I & Grade II Stenographers of BSNL field units who were made PA w.e.f. 1.1.2004.

Sir,

As already conveyed vide this office letter No.400-61/2004-Pers.I(pt.I) dated 23<sup>rd</sup> August, 2011, I am directed to state that a Committee under the Chairmanship of PGM(FP) was constituted to look into the matter of recovery of excess pay as per clarification issued vide this office letter of even no. dated 13.10.2010. Based on detailed examination of the issue, the committee has recommended grant of Residency in the upgraded IDA pay scale of Rs.9850-250-14600(pre revised) w.e.f. 1.10.2000 to Stenographers Grade-I and Grade-II of BSNL field units who were made PAs(i.e. Executive) w.e.f. 1.1.2004 by way of restructuring of the Cadre, vide this office letter No.20-8/2002-Pers.II dated 20.02.2004, only for the purpose of eligibility for first time bound IDA pay scale upgradation. However, the pay of these officials shall continue to be fixed in their respective non-executive pay scales prior to 1.1.2004 (i.e.1.10.2000 to 31.12.2003), and as ordered in this office order No.400-61/2004-Pers.I dated 24.08.2007, **there would not be any notional fixation of pay etc. in the Executive/PA grade from 1.10.2000 to 31.12.2003 in respect of these officials.**

Further, statement relating to this issue given to the court in r/o O.A. No.142/2011 filed by BSNL Personal Staff Association Vs. CMD, BSNL in the Hon'ble CAT, Ernakulam or any other earlier court cases may be modified accordingly.
