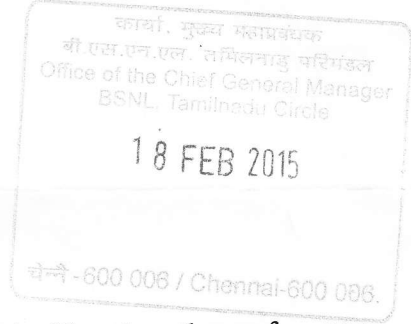

Sub: Clarification on officiating pay protection for executives promoted prior to 1.10.2004.

Ref: This office letter of even no dated 25.10.2013, 27.11.2013 and 19.5.2014.


Kindly refer to this office letters cited above regarding clarification of officiating pay protection for executives promoted between 1.10.2000 to 30.9.04.

The pay of the officers promoted between 1.10.2000 to 30.9.2004 in the cadres of AAO/JTO LA/ Sr AO/ Sr SDE have been fixed with reference to FR 22 I (a) I counting the officiating periods as per FRs.

Before issue of Executive promotional policy order, all the officers those who were officiating have got the benefit of fixation of pay including the officiating spells.

It may be clarified whether the pay already granted under FR prior to the introduction of EPP order dated 18.1.2007 and clarificatory order issued in this connection vide order dated 19.2.2010 to the officers promoted between 1.10.2000 to 30.9.2004 whose promotions are treated as first upgradation, has to be fixed under FR provisions or not.

The clarification in this regard may kindly be issued at the earliest.
