Sub: Looking After in the grade of Sub Divisional Engineer (T) - reg

It is proposed to fill up the vacancies of S.D.E.s (Telecom) by local looking after arrangements to the extent of requirement as per the restructuring orders issued by this office and in accordance with guidelines contained in BSNL Corporate Office letter No. 19-27/2002 dated 15/04/2004, and looking after arrangement by executives availing higher scale of pay with instructions contained in BSNL Corporate office letter No 412/13/2013-Pers (I) dated 22-3-2013. Accordingly options are hereby called for from among JTOs of Tamilnadu Circle including those JTOs who were looking after as SDEs, whose year of recruitment is 2006 or earlier, and those JTOs completed /not completed debarred period. (Eligible SC/ST officers up to 2006 Y.O.R or who have completed 3 years of service in JTO cadre may also opt) with the following conditions. Details of SSA vacancies as on date available are given in the Annexure.

- 1. Existing options will be null and void.
- 2. The officers who have not completed 2 years cannot exercise option for change of station till they complete 2 years in the present looking after station.
- 3. Heads of SSA/Unit may collect 3 options of SSA, from each JTO, in the order of priority.SSAs should not be the same in all the three options. Head of the SSA will decide the station of postings, as per the existing guidelines.
- 4. Option from the SDEs who were looking after and completed 2 years in the present SSA may also be obtained indicating their choice as per the standard format given below. But the transfer will be on own cost of the officer.
- 5. JTOs while giving options should clearly indicate whether they would like to be considered for posting to ANY SSA other than the options given by them or they would like to be skipped.
- 6. The consideration as for as practicable will be on seniority-cum –fitness, and eligibility basis, However for specific administrative requirements, discretion will lie with the administration.

- 7. Debarred officials can exercise their options, but will be considered only after the debarring period.
- 8. No subsequent changes in options will be accepted till next options are called for.
- 9. The vacancies shown in the Annexure are approximate and tentative and the actual filling up of posts will be decided based on the actual vacancy.
- 10. Options may be exercised for SSAs where vacancy is not declared as on date. (These options will be considered for future postings)

11. Consolidated options may be sent to this office by the SSA/Unit administration through Intranet in the following MS Excel Format as "JTO optionXXX.xls" to the folder "circle office /staff /AD staff I", which should be made available on or before 10/05/2013 in the standard format given below.
