# 1. Short title and commencement:-

- i) With the approval of BSNL Board, the following rules regulating the method of recruitment to the post of Lower Division Clerk in BSNL Corporate Office are hereby made, namely;
- ii) These rules may be called the Lower Division Clerk, Recruitment Rules, 2009 (Issue No: 1).
- iii) They shall come into force with immediate effect.
- **2. Definition**: In these rules, unless the context otherwise requires,
  - **Company:-** means Bharat Sanchar Nigam Limited (A Government of India Enterprise) having its Registered Office and Corporate Office at Bharat Sanchar Bhavan, Harish Chander Mathur Lane, Janpath, New Delhi -110 001.
  - **Board:-** means the Board of Directors of the Company and includes in relation to the exercise of powers any Committee of the Board/ Management or any Officer of the Undertaking to whom the Board delegates any of its powers.
- **3. Application**:- These rules apply to the posts specified in Column(1) of the Schedule annexed to these rules.
- **4. Number of Post, classification and scale of pay:** The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

Method of Recruitment, age limit, qualifications etc.:-The method 5. of recruitment, age limit, qualification and other matters relating to the said post shall be as specified in columns 5 to 12 of the said Schedule.

### Disqualification:- No person, 6.

- Who has entered into or contracted a marriage with a person having a spouse living, or
- b) Who having a spouse living, has entered into or contracted marriage with any person, shall be eligible for appointment to the said post.

Provided that the Central Govt. may permit a Govt. servant to enter into or contract any such marriage as is referred to in

clause (a) or clause(b), if it is satisfied that \_

- such marriage is permissible under the personal law servant and the other applicable to such Govt. party to the marriage: and
- there are other grounds for so doing. ii.
- Service under the Territorial Army:- A Lower Division Clerk who 7. has not completed the age of 40 years, if so required, will be liable to serve in the Territorial Army subject to the provisions of Section 6A of the Territorial Army Act, 1948 (58 of 1948) and the rules made thereunder.
- Saving: Nothing in these rules shall affect reservation, relaxation of 8. age limit and other concession required to be provided for the Scheduled Caste, Scheduled Tribes, other Backward Classes, Ex-serviceman and other special category of persons in accordance with the orders issued by the Central Government from time to time in this regard.

### Initial constitution:-9.

- All officials holding the post of Lower Division Clerk on i) regular basis in Bharat Sanchar Nigam Limited as on the date of issue of these Recruitment Rules shall be deemed to have been appointed as Lower Division Clerk with the same seniority.
- The continuous regular service of officials referred to in subii) rule 9(i) above before the commencement of these rules shall count for the purpose of probation, qualifying service for promotion, confirmation and pension.
