### Subject: Rationalization of Prepaid Broadband Tariff under Prepaid Broadband services on DSL access- reg.

Kind reference is invited to this office letter No. 1-1/2009-R&C [CFA] dated 19.10.2009 & 22.06.2010 (i.e. Circular R&C-CFA No. 09/09-10 & 07/10-11)) regarding tariff structure for prepaid broadband services and introduction of Volume based recharge vouchers under Prepaid Broadband services on DSL access.

The tariff of Pre-paid Broadband service has been reviewed in this office and the Competent Authority has decided to rationalize the Prepaid Broadband tariff as follows:-

### A. Initial Charges at the time of application:

#### # Procedure to be adopted to have proper accounting and charge deduction in case of modem rental option:-

- 1. The Prepaid BB customer, who opts for modem rental option, has to deposit the refundable security deposit for modem (as prescribed) through demand note at the time of application.
- 2. Initially and in subsequent months, customer has to recharge his prepaid account with modem rental voucher according to the type of modem with him. This will be in addition to normal recharge vouchers which provide usage and account validity. Customer may also recharge his account with a number of modem rental vouchers at one time for multiple month modem rental validity.
- 3. The customer's prepaid account shall be active and usable only when both modem rental validity & account validity are available. If any of the validity has expired, customer's account shall be suspended.
- 4. In case, customer has not recharged his prepaid account with modem rental voucher for certain duration, he has to recharge the same with modem rental voucher for entire past duration in order to use his prepaid account.
- In case, customer returns the modem in working condition after expiry of modem rental validity, the security deposit 5. against modem shall be refunded to him after deducting the monthly modem rental charges for the period between date of expiry of modem rental validity and date of returning the modem.

## C. Renewal/Recharge of account:

- 1. The customer can recharge his account online from the BSNL portal by making online payment or after purchasing the voucher either through BSNL Customer care centers or other retail outlets.
- 2. In case customer opts for migration from unlimited plan to limited plan vouchers or vice versa, his/her validity/balance usage (if any) shall not be carried forward. The account will be treated as a fresh account. However, the customer will be able to retain his user account.
- 3. In case customer migrates from one unlimited plan to other unlimited plan voucher **with different bandwidth**, the new bandwidth along with new validity will start. In such cases, if any validity is available under earlier unlimited plan voucher, it shall not be carried forward.
- 4. In case customer migrates from one limited plan to other limited plan voucher **with different bandwidth**, the new bandwidth along with new validity will start. In such cases, if any validity is available under earlier limited plan voucher, it shall not be carried forward. Only unutilized usage part (if any) shall be carried forward provided customer recharges his account upto Grace Period-1 (GP-1) period.

# D. The above tariff will be applicable w.e.f. 01-08-2011.

- E. All other relevant terms and conditions shall remain same as contained in letters No. 1-1/2009-R&C [CFA] dated 19.10.2009 & 22.06.2010 (i.e. Circular No. 09/09-10 & 07/10-11) and BB Cell letters No. 64-27/2009 Broadband – Prepaid/ dated 14-12-2009 and 24-12-2009.
