The Telecom Circles have sought extension of time, mainly on the following grounds/justifications:-

- Difficulties occurring in finalization of tenders for CAF and photograph scanning due to various reasons like single bidder participation, quoting abnormal rates, bidder technically disqualified, bidder not interested to do the work and delay in connectivity to CCDG servers.
- The work was delayed due to change of format by TERM Cell as in the earlier format, the file size was huge although the half of work of cropping images in some Circles was completed. TERM Cell has later instructed that the file size should not be over 50KB and the image should contain only photograph of the customer with file name as Mobile Number Date of Activation.

- During scanning work difficulties are being faced due to huge data base to be prepared and also there are the probabilities of mistakes due to reused mobile numbers as presently there is no provision in software to prepare such data base as it was mainly designated for scanning purpose only.
- Besides in the case of Odisha Telecom Circle, presently, there are about 36 lakhs of mobile subscribers and every month 65 thousands subscribers are getting added. Till Now 52% CAF scanning work has been completed Further due to Phailine Cyclone dated 12.10.2013, almost 3 lakhs CAFs of Baripada SSA of this Circle were washed away and till now only 30% of CAFs of this SSA have been recovered. The work of scanned photography has been started in Dec., 2014 and it is a time taking process, approx. 1.2 lakhs photographs are being scanned per month. It will take approximately one and half year time for submission of scanned photograph to TERM Cell so dead line for submission of scanned photograph is required to extend up to May, 2016 being a special case.

Accordingly, it is again requested to kindly grant extension of time as sought for the above mentioned Telecom Circles/ District for submission of scanned CAF and cropped photographs in respect of connections acquired since 09.11.2012 onwards to concerned TERM Cells, as these are still in process in most of the Circles.
