On the basis of recommendations of tariff Committee, the competent authority has decided "to introduce promotional scheme to offer 50% installation fee waiver for new Landline, Broadband, Landline+Broadband connection for a period of 90 days in Tamilnadu circle only.

The details of promotional scheme are as follows:-

- a) To waive off Rs. 375 (for Urban customers) and Rs. 275 (for Rural customers) on installation fee under new Landline Connection category.
- b) To waive off Rs. 125 on installation fee under new Broadband connection category over existing Landline connection.
- c) To waive off Rs. 500 (for Urban customers) and Rs. 400 (for Rural customers) on installation fee under the category of new 'LL+BB' connection.

2. The circle will ensure to comply with all regulatory mechanism.

- 3. All other terms and conditions shall remain unchanged.
- 4. The above scheme shall be applicable w.e.f. 15-08-2014 on promotional basis for 90 days in Tamilnadu circle only.
