Subject:- Withdrawal of Gramin – 75 plan in Rural Area.

Reference is invited to this office letter no 3-21/2008-R&C dated 19-08-2008 (Circular No. 32), vide which the above mentioned plan was introduced in Rural Area. The matter was reviewed in this office by CFA Tariff Committee and it is felt that said plan needs to be withdrawn *in view of recent revision of call rates of General plan in rural areas, which are at par with Gramin- 75.*

The recommendations of the Tariff Committee to withdraw the Gramin – 75 plan have been approved by the Competent Authority, subject to the following:-

- 1) The existing customers of Gramin -75 shall be migrated to corresponding General Plan of the area.
- 2) The above order shall be effective from **1st Dec, 2013.**
- 3) Circles will monitor the impact of this change closely, in case of surrender in this plan specifically; the fault history of such customers should be referred.
- 4) All regulatory requirements may be complied with while implementing the above order.
- 5) The impact of this change may be analyzed and report may be submitted immediately after one month of implementation to PDP-CFA BRANCH of Corporate Office through email at PDPCFA@gmail.com.
- 6) The Circular is issued based on approval of the Competent Authority in PCP-CPFA Unit File No. 8-23/PDP-CFA/2012-13. For any clarification / correspondence in respect of aforesaid scheme, matter may be taken up with PDP-CFA unit of BSNL CO, New Delhi – 110001 at Tele. No. 23322692.
