Kindly refer to this office order/clarification of even No. dated 15.02.2013, 24.07.2013 and orders issued from time to time vide which ISD tariff while national roaming has been rationalized. Now based on CFA cell Circular No.3-1/2010-R&C (CFA) dated 19.11.2013, it has been decided by the Competent Authority to revise the code wise ISD tariff for BSNL customers roaming in MTNL network and IOT applicable to MTNL for its customers roaming in BSNL network. The revised tariff is as per **Annexure-I**.

- 2. For BSNL customers roaming in BSNL network, the existing ISD tariff as applicable while in home LSA will be applicable.
- All other terms and conditions will remain the same.
- The above tariff will be applicable with effect from <u>05.12.2013</u>.
- 5. This may be brought to the notice of all concerned for taking necessary action. The implementation of the revised tariff is to be made in accordance with 43rd Amendment of Telecom Tariff Order issued by TRAI. Customers may be suitably informed about revision in tariff. Circles have to revise the circle based plans, update their website and report the same to TRAI as per tariff reporting requirement of TRAI.
