Subject: Inclusion of left out ISD Codes of KAZAKISTAN in ISD Tariff list-reg.

Kind reference is invited to this office letter No. 3-1/2010-R&C (CFA) dated 31.07.2012 prescribing tariff for ISD calls made to destinations mentioned therein. It has been reported by field units that calls made by customers to certain Area Codes of KAZAKISTAN, which are not mentioned in said tariff Circular, are being charged at higher rate by default.

2. The matter was examined by the Tariff committee in this office and it has been confirmed that Carrier Charges to these left out Area Codes of KAZAKISTAN are same as to those mentioned in tariff circular dated 31-07-2012. The committee has recommended for charging ISD calls made to these areas at same rates i.e. Rs. 10/- per minute at par with those Area Codes mentioned in tariff circular under reference. The recommendations of tariff Committee have been approved by the Competent Authority.

Accordingly, the approval of Competent Authority is here conveyed for charging the ISD calls to these left out areas as follows:
