- Whenever international carrier rate exceed 80% of ISD Tariff, DGM (D-TAX) shall inform Sr. GM(NWO-BB/IN), Sr. GM(PP-CM) & GM (ILD) , so that corrective action can be taken. Further whenever carrier charges exceed 90% of the ISD TARIFF, DGM (D-TAX) will block the route and immediately inform to BSNL CO New Delhi.
- If any country is left out from the list above, this should be intimated to BSNL CO New Delhi for review and till then existing ISD Tariff of such left out country shall remain unchanged.
- **Revised ISD TARIFF shall be implemented w.e.f. 1st Dec, 2013.**
- NWO-CFA Unit shall issue the new charge band wherever required.
