Subject:- Review/Revision of ISD Tariff for all countries for UITC , FLPP Gen. & FLPP PCO—Reg.

Kindly refer to this office letter No. 3-1/2010-R&C (CFA) dated 19.11.2013 (circular no R&C-CFA No. 80/13-14) carrying approval for revision of ISD Tariff for calls made from landline /PCOs & further clarifications issued vide letter no. 3-1/2010-R&C (CFA) dated 7.01.2014 (Circular R&C-CFA No. 79/13-14). It has been decided by the Competent Authority to implement the said revised ISD Tariff for UITC, FLPP Gen. & FLPP PCOs, having following plans/scheme:

- (i) UITC in Rs/Minute with 60 sec pulse & Corresponding Paisa /Sec with 1 second pulse
- (ii) FLPP(Gen.) on MCU basis with pulse duration in Sec. & pulse rate of Rs. 1.20
- (iii) FLPP PCO tariff on MCU basis with pulse duration in Sec. & pulse rate of Rs. 1.00

- Comprehensive list of countries / Codes with ISD Tariff is given in **enclosed Annexure**
- If any country is left out from the list above, this should be intimated to BSNL CO New Delhi for review and till then existing ISD Tariff of such left out country shall remain unchanged.
- Revised ISD TARIFF shall be implemented **with immediate effect.**
