Subject: Revision of Installation Charges in case of New Telephone Connections (NTCs) being provided with Telephone instrument having CLIP facility.

The Competent Authority has approved revision of installation charges for New Telephone Connections (NTCs) both for Rural and Urban areas where the Telephone Connection is provided with instrument having clip facility, the cost of Clip Instrument being more than conventional PBT.

2. It has also been decided by the Competent Authority to extend the benefit of rebate of additional 300 MCUs over and above the normal free MCUs (to be distributed equally in three billing cycles @ 100 MCUs per billing cycle applicable from 2nd bill) initially launched on promotional basis vide letter No 3-4/2009-R&C [CFA] dated 16-06-2011 (Circular No. 06(11-12), on regular basis in all Circles with modification that <u>concession to subscribers opting for own instrument including Clip instrument, shall be available in the form of additional 300 MCUs only and other concession of charging reduced installation charges, shall</u>

not be admissible henceforth. The revised charges/concessions are as follows:
