## Subject: Revision of free call, bifurcation into ONNET/OFFNET and revision of call charges after free call in Rural General plan.

Based on the recommendations of Tariff Committee – CFA, Competent Authority has approved the revision of free call (bifurcation into ONNET/OFFNET) and call charges beyond free call in Rural General plan. The detail of the revised plan is as follows:

Call Charges after free calls	Rs.0.80 for(<300 MCU) Rs.1.20 for (>300 MCU)	Rs.1.00 for ONNET calls Rs.1.20 for OFFNET calls

- 1) All other terms and conditions shall remain unchanged.
- 2) The above charges will be applicable on PAN India Basis w.e.f. 01-12-2013.
- 3) The Circle should ensure to comply with all regulatory requirements.
