Reference is invited to this office Circular no. 44(12-13) was issued vide letter no. 3-4/2009-R&C[CFA] dated 27.11.2012 conveying approval regarding splitting of MCUs as ONNET and OFFNET usage for the purpose of allowing free calls and application of revised tariff per MCU for OFFNET calls upto 300 MCUs. The same could not be implemented by ITPC due to technical reasons.

2. In view of above, the matter has been further reviewed in this office and it has been decided by the Competent Authority to revise tariff for General (Urban) & One India (urban) plans as follows:
