Subject: Withdrawal of Annual Plan (1) Plan-600(Rural), (2) Plan-1200(Urban) & (3) Plan 2160(Biennial) - reg.

- 1) Kindly refer to this office letter of No.3-18/2005-R&C dated 23.04.2008 (Circular No.6) through which the annual /biennial fixed charges plans for Landline and WLL Services viz. Plan-600 & Plan 1000 in Rural Area and Plan 1200, Plan 1800 & Plan 2160 (Biennial) in Urban Area were introduced. Subsequently annual Plan-1000 (Rural) and Plan-1800 (Urban) were withdrawn vide this office Circular No.04/10-11 issued under letter of No.3-11/2009-R&C [CFA] dated 31.05.2010.
- 2) The remaining plans viz. Plan-600(Rural), Plan-1200(Urban) both & Plan 2160 (Biennial) Urban were also withdrawn vide letter no 22.02.2013 (Circular No. 60/11-12). However, on the basis of feedback received from some of the field units, these plans were restored for existing customers only vide letter no. 3-11/2009-R&C[CFA] DATED 03.05.2012 (Circular No. 04/12-13) Para 2.i. HoCs were authorized to withdraw the said plans vide Para 2.ii by offering alternative plans mentioned below Para 2.iii of said letter dated 03.05.2012.
- 3) The matter has been further reviewed in this office and it has been decided to withdraw the above plans and alternative plans (as discussed in Para 2 above) henceforth. The existing customers under these plans shall be allowed to continue till the expiry of committed period. After expiry of committed period, existing customer under these plans may be migrated to the any plan chosen him including annual/two years/three years advance payment plans introduced vide letter No. 3-4/2009-R&C-CFA dated 13-03-2013 (circular No. 72/12-13) or general plan.
- 4) These instructions shall have immediate effect.
- 5) This may be brought to the notice of all concerned for taking necessary action.
