Kindly refer to the letters enclosed here with addressed to PGM/GMs of all the SSAs by the DGM (EB) dated 16-01-2013, 14-05-2013 and 16-05-2013 respectively regarding payment of bills for the Broadband connections provided to 1840 Higher Secondary Schools across Tamilnadu through ELCOT.

As per the letter dated 16-01-2013 it was requested to raise the bills for the outstanding amount due from the Higher Secondary Schools as per the rates applicable to ELCOT. Since the first year amount already been raised and paid by ELCOT the bills from the second year and subsequent period bills are to be raised for **annual payments @ Rs.5500/- + Service Tax** to the respective schools immediately by the SSAs.

The list of broadband connections provided has already been uploaded in the Intranet along with the letter dated 16-05-2013.

The copy of letter addressed to Chief Education Officers of the districts by the Director Education regarding making of payment for the broad band connections dated 02-05-2013 is also enclosed for ready reference. It is further requested to update the payments immediately on receipt of payment in order to wipe out the outstanding against the schools.

they are not able to pay the amount actually due.

As per this office letter dated 16/01/2013, it was requested to raise the Bills with
the outstanding amount due to the respective schools, as per the ELCOT rates.

The first year amount has been raised and paid by ELCOT for these higher
Secondary Schools. For the Second year and the subsequent period, Bills are to be
raised for Annual payments @ **₹ 5500/ + ST.** to the respective individual schools.

Since the Higher Secondary School results are announced and the Employment Online Registration is due during next week, the Broadband connectivity is very much essential for the Hr Sec Schools and the due payments can be persuaded easily.

Sub: Billing and Collection of charges for Broadband connections provided to Higher Secondary Schools through ELCOT – reg

Broadband connectivity has been provided to 1824 Higher Secondary Schools across Tamilnadu thro M/s ELCOT under ELCOT Plan. Payments for these broadband connections are due for the Second and subsequent years. ELCOT had not paid the charges for the second year and subsequent periods for these connections and after repeated persuasion, it was intimated that Central fund is not available for these Higher Secondary School Broadband connections. This issue has been pursued with Secretary, School Education and Director School Education. But till date there was no response from the Education Department.

Hence, EB Unit TN Circle has addressed and sent letters to the District CEOs to arrange for the payment through the respective Schools. The copy of the letters are uploaded in Intranet.

In order to realize the outstanding payments, the Bills are to be delivered to respective schools. For these Higher Secondary Schools ELCOT BB Connections, if the Billing address is different from that of Installation address, the Billing address has to be changed and the Bills are to be raised to the respective Higher Secondary School, so that the Schools are made aware of the outstanding amount.

SSA units are requested to meet the District CEOs along with this letter and pursue the payments. It has to be informed that any further delay in paying the dues will lead for "Disconnection". Based on the response from the CEOs the further course of action, like "disconnection" etc can be decided in concurrence with TN Circle EB Unit.

In the absence of any positive response within a period, all the Broadband connections for the Higher Secondary schools in the Entire district can be disconnected for Non-payment.

The Non availability of these services is to be highlighted to respective CEOs and respective schools. Vigorous efforts are to be undertaken to realize the pending payments.
