Subject: Tariff for Secure Email Filtering Services and Secure Web Filtering Services to be offered from Internet Data Centers set up on revenue share basis with M/s Dimension Data- regarding.

BSNL CO has placed Work Order for Setting up, Own and Operate Internet Data Center (IDCs) in BSNL on Revenue Share basis to M/s Dimension Data India Limited for 6 BSNL sites & M/s SIS India Limited (Data Center Service Provider "DCSP") for 4 BSNL sites. As per letter no. BSNL/BBNW/IDC/2011-12/BILLING & COLLECTION DOC/6 dated 16th November'11. CGM BBNW Circle has been designated as Nodal Authority for implementing and selling of data centre services from 10 Data centres namely Faridabad, Ghaziabad, Ludhiana, Ahemdabad, Jaipur and Mumbai managed by M/s Datacraft India Limited (Now Known as M/s Dimension Data) and Alappuzha, Banglore, Hyderabad and Ranchi Managed by M/s Sai Infosystem India Limited (SIS).

- 2. The Tariff Card for Managed Co-location, Hosted Exchange & Hosted Video Conferencing services and Hosted Computer services to be offered from IDCs setup on revenue share basis with M/s Dimension Data has already been issued by IT-CFA section vide letter no. 13-2/2011-IDC/IT-CFA/Vol III dated 30.12.2012 and 13-2/2011-IDC/IT-CFA/Vol III dated 11.01.2012.

#### 4. Other Terms and conditions:

- 4.1 CGMs of the respective circles are authorized to give discounts up to 30% on the price as in the tariff card to customers depending on the volume of Business/strategic relationship with customer. For extending discounts more than 30% in specific cases, CGMs of the respective circles shall refer the cases to corporate office for prior approval.
- 4.2 The rates mentioned in the above tariff card are for the IDC services only and do not include charges for bandwidth requirement by the customers. The rate for the bandwidth portion shall be offered by BSNL and circle shall quote them as per the prevailing practice at that point of time.
- 4.3 Before submission of proposal to end customers by BSNL, it shall be ensured that back to back technical proposal is available from M/s Data Dimension for the respective customer.
  - 4.4 Above mentioned rates of various services are excluding of S. Taxes.
  - 4.5 Other commercial conditions and revenue share details etc. will be same as issued by BBNW Circle and IT-CFA.
  - 4.6 Head of Account for IDC services will be issued by the CA section.
