### Rate Structure for IPv6 Specialized Training Module by BSNL

# 1. Awareness Programme – General (At BSNL Facilities) <u>- Rs. 3000/- per participant</u>

These are similar programme "being organized by BSNL with the financial support and coordination of DOT" except that these shall be conducted regularly in BSNL training centers on a weekly basis. Participants would be from mix of organizations, as against the programme by BSNL with the financial support and coordination of DOT which will be organized exclusively for any organization.

# 2. Awarness Programme – Exclusive (At Client's Facilities) - Rs. 16,000/- Travel/Board/lodge per expert

These progorammes would have the same flavor as exclusive awareness programme, except that these would be conducted at client's facilities. The experts from the working Group would travel to the client's premises.
