NIC is the implementing agency for e-courts Mission Mode Project (MMP) across the country. As per the guidelines contained in the BSNL HQ letter No. BSNL/BD/e-Governance/2004 dated 12-04-2007(available on BSNL Intranet under BD section) for all e-Governances project of Govt. of India, BSNL is providing 20% discount for the VPNoBB connections which are more than 5000.

NIC which is the booking authority for different government projects under e-Governance including the e-court project for Department of Justice. It has booked more than 5000 VPNoBB connections under e-Governance so eligible to have 20% discount as per the guidelines contained in the BSNL HQ letter No. BSNL/BD/e-Governance/2004 dated 12-04-2007.

Now NIC vide its letter dated 20-02-2013 has indicated that empowered committee of e-court project took decision to decentralize implementation of VPNoBB component of e-courts project to various high courts. It is further indicated that process of applying for obtaining VPNoBB is decentralized under the same e-court project and requested BSNL to give 20 % discount for VPNoBB connections to all High Courts for e-court MMP.

The issue has been examined in BSNL C.O. and the competent authority has approved 20 % discounts for VPNoBB connections to all high courts for e-court MMP. Henceforth application may be accepted from the respective High Courts under the Telecom Circle for booking of the VPNoBB connections under e-Court project.
