Subject: Clarification on Voice only facility on FTTH – reg.

Kindly refer Circular R&C-CFA No. 43/13-14, circulated vide letter of even no. dated 14-10-2013, regarding "continue/extend voice only facility on FTTH on any landline Plan having minimum FMC of Rs. 180/- and above", subject to the conditions as mentioned therein.

2. In this regard, it is clarified that No Free Calls shall be offered on the FTTH connection having Voice only facility with FMC as Rs. 180/-. Also the charges for the calls made under this plan shall be Rs. 1.20/- per MCU on any network (i.e. both on On-Net as well as Off-Net).
3. All other terms and conditions, as mentioned in earlier circulars, shall remain unchanged.
4. This clarification is issued based on the approval of Competent Authority in Broadband Cell File No. 64-03/2009-BB.
