Kindly refer BP-Enterprise unit circular no. 111-05/2012-BP-Ent dated 30-04-2012, vide which under para 2.3, it is mentioned that "any combination of current tariff plans of landline voice, BB and IPTV, including the BB combo plans, may be allowed to the subscriber subject to the total minimum FMC commitment of Rs. 499/- and above.".
