Sub: Revision of GPRS/EDGE tariff under 2G mobile data services - req.

Kindly refer to this office order of even No. dated 23.08.2010 and orders issued from time to time vide which GPRS/EDGE tariff was intimated. Now, it has been decided by the Competent Authority to rationalize the GPRS/EDGE tariff in 2G postpaid and prepaid mobile data services as under:-
