Tablet- 3G SUK Data Plan – ACTIVATION PROCEDURE

- The vendor will make a payment of **Rs.209 for 3G USIM** through RTGS to AO-CMTS, Trichy.
- After getting the confirmation from TR-AO (CMTS), DE Commercial ,CBT will issue the 3G USIM to the vendor ,who will come and collect it from Coimbatore.
- The Tablet Vendor or his Agent has to enter the SIM Number and the Random number at the top of the CAF, while issuing the SIM to Customer along with the Tablet.
- The SIM stock will be in the name of the Vendor, but will appear to all CSC/Franchisees on entering the 3G USIM No. after selecting the Menu in Tablet/Data Device in Sancharsoft. CSC/Franchisee has to enter the correct **7 Digit Random number in IMEI column manually** and SIM number manually like PTPL Tablet/3G Data card Plan.
- The CAF entry will be done either by CSC or by BSNL Franchisee. Number can be selected thru' choose your mobile number.
- After entering the Address Data entry in Sancharsoft, the number will be activated in IN based on the Plan.
- The eligible 3G Free data usage will be set in IN only on applying the Plan voucher 102 by the customer through C-Top Up.
- The Main Account validity will be set 365 days from the date of 1st call.(*123#) and the Free data usage 2GB with 3G Speed will be set accordingly.
- If the customer fails to apply Plan Voucher 102, within 22 days from the date of creation, the number will be liable for deletion.
