field units/Nodal centers, the following clarification/orders are issued.

Queries	Clarifications
i) Whether INMARSAT rate of 450 Rs/Minute is applicable to CDMA/RUIM (Limited Mobility/Full Mobility). If applicable what should be the Pulse rate for CDMA/RUIM Plans, whether 200 Milli sec (vide C.O. letter No. 3-22/2008-R&C dated 4-11-2008 or 60 sec.	i) INMARSAT tariff is applicable to CDMA/WLL also. The pulse rate for INMARSAT call is 60 sec.
ii) Whether Fixed INMARSAT charges Rs. 50 (vide CO letter No. 3-22/2008-R&C dated 4-11-2008) are still applicable or Only variable charges of Rs.450 /Minute is to be applied.	ii) Fixed INMARSAT charges of Rs. 50 is not applicable. Only variable charge of Rs.450/Minute is to be applied.

vi) What about the ISD video calls?	vi) At present there is no tariff for ISD video call.
vii) As it is technically not feasible to charge differently for same country code destinations, we have charged maximum for the countries "Mayotte and Yugoslavia". Please confirm.	vii) ISD tariff for Camoros Mayotte at SI. No. 47 and Mayotte at SI. 131 of this office order dated 14.12.2011, is uniformly fixed as Rs.40. ISD tariff for Kosovo at SI. No. 107 and Serbia at SI. 176 and Yugoslavia at SI. 224 of this office order dated 14.12.2011, is uniformly fixed as Rs.15.
