As per letter under ref. (1), Introduction of SUK (MRP Rs.100) for Bundled data cards under GSM services wef 2.7.12 was communicated.

Approval of the competent authority is conveyed for the revision in price of Start-up Kit (SUK) for activation of data plan for Bundled data cards under 2G/3G prepaid mobile services in **Tamilnadu LSA** (incl. Chennai Telecom District) with effect from **01.09.2012**.

i) The details of Start-up Kit (SUK) are as under :-

- ii) The MRP of SUK includes price of Normal SIM (2G SIM). If the customer needs USIM he has to pay separately for the USIM. i.e. Rs.59.
- iii) The SUK is to be physically bundled with data card and not to be allowed for sale as standalone sale of USIM.
- iv) Henceforth, Plan activation to prepaid data plan with the sale of BSNL data card (including reverse bundling) will be through SUK Rs. 45 or SUK Rs. 104 only.
- v) The activation procedure in respect of Forward/Reverse Bundling of BSNL data card is given below:

Forward bundling:

- As per subs request, 2G SIM/3G USIM on stock with CSC can be issued.
- CSC has to issue **2G SIM/3G USIM** to Customer along with Data device on receipt of **Device cost+ Rs 96/- for 2G SIM** (SUK Rs.45/- + Plan voucher Rs.51/-) or Rs.**155/- for 3G USIM** (SUK Rs.45+USIM Cost Rs.59+PV Rs.51)
- Sale of SIM (2G/3G) is linked to sale of data card and Sale entry of Data Card (i.e. IMEI No.) is mandatory. CSCs should ensure the same for activation of data plan.
- The customer will be given free data usage of 1GB+200 MB which is to be used within 30 days on activation and the Main account validity will be 365 days from the date of activation. i.e from first call set (*123#)

Reverse Bundling

- The Data card vendor has to give the IMEI number to Mktg II Circle Office, Chennai for the 2G SIM/USIMs required.
- The IMEI of the 3G data card will be forwarded to Comml wing, CBT to get uploaded in Sancharsoft.
