Kindly refer to this office order of even No. dated 03.01.2013 and orders/clarifications issued from time to time vide which tariff for STV 44 with feature of 1p/2 sec was revised under 2G & 3G prepaid mobile services. Now, it has been decided by the Competent Authority to **modify the features** of the STV 44 as under:-

i) STV with revised/modified feature and validity:-

44	Local- Any-Net call @ 1.2 p/2 Sec	30	Modified

ii) All other terms and conditions will remain same.

iii) The above revision will be implemented with effect from **14.06.2013**.

2. This may be brought to the notice of all concerned for taking necessary action in this regard. The implementation of the revised tariff is to be made in accordance with 43rd Amendment of Telecom Tariff Order issued by TRAI. Customers may be suitably informed about the modification in feature of the STV.

3. Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.
