Sub: Revision in tariff of data plan/STVs under mobile services – reg.

Ref: No.26-17/2009-R&C (Pt) Circular T&C-CM No. 29/13-14 date: 08.08.2013.& 30/13-14 date 14.08.2013

Approval of the competent authority is conveyed for the implementation of Uniform 2G & 3G Prepaid DATA STVs in **Tamilnadu LSA** (incl. Chennai Telecom District) with effect from **15.08.2013.** The details of Unified Data Special Tariff Vouchers are as under:-

\*These four new Data STVs will be implemented for a promotional period of 90 days wef 15-08-2013 to 12-112013

- All the above STVs can be activated either through C-TOP UP or through SMS.
- All existing 3G Data STVs (including YUVA) of MRP Rs. 25,53,101,155,252,452,751,1299,124 & 599 in C-TOP UP and the respective SMS Keyword to 53733 are withdrawn wef 15/08/2013.
- However, existing 3G Data STVs of MRP Rs.601 & 3302 and 3G Combo Date STVs of MRP Rs.899, 535 & 177 and 3G Combo STV Rs.345 will continue to exist.
- All existing GPRS/2G Data STVs/Combo STVs of MRP Rs. 302,270,125,98,54,14,7,62 & 105 with SMS Keyword to 53733 are withdrawn wef 15/08/2013.
- For Pre-paid 2G Data Customers, who have recharged 2G Data STVs till 14/08/2013, the customer profile is to be converted to default profile of 3G with **no speed restriction from 15/08/2013**.
- The customer profile in the new unified Data STVs will be 3G with no speed restriction.
- The 2G and 3G Blackberry plans uses blackberry APN, hence blackberry 2G and 3G tariff plans will remain unchanged.
- The PTPL 2G and 3G plans with their respective STVs will also remain unchanged.
- All other terms and conditions of prepaid GPRS/Data STVs will remain same.
