Sub: Revision of national roaming charges for BSNL customer while roaming in MTNL network -reg.

It has been decided by the Competent Authority to revise the national roaming charges applicable to BSNL postpaid and prepaid GSM/CDMA customers while roaming in MTNL network as under:-

2. However, BSNL customer while roaming in BSNL network, the existing tariff for national roaming will be applicable.

3. All other terms and conditions will remain the same.

4. The above tariff will be applicable with effect from **01.03.2013**.

5. This may be brought to the notice of all concerned for taking necessary action. The implementation of the revised tariff is to be made in accordance with 43rd Amendment of Telecom Tariff Order issued by TRAI. Customers may be suitably informed about revision in tariff. Circles have to revise the circle based plans, update their website and report the same to TRAI as per tariff reporting requirement of TRAI.


