## Circular T&C-CM No. 110/12-13

### **Sub: Introduction of STVs under 2G & 3G prepaid mobile services-reg.**

It has been decided by the Competent Authority to introduce the following new STVs under 2G & 3G prepaid mobile services.

#### **A. Local On-net call STVs:**

3. The above STVs will be launched with effect from **29.01.2013**.


